

## TERMS OF USE FOR MASTERCAM COPILOT (WEBSITE)

### 1. DEFINITIONS

In this document (the “**Terms of Use**”):

The following words and phrases shall have their respective meanings given below:

“ <b>License</b> ”	means a non-exclusive, non-transferable, non-sublicensable, revocable, and limited license to use the Mastercam Copilot and the Outputs.
“ <b>Mastercam Copilot</b> ”	means the Licensor’s chatbot / Mastercam Copilot product known as “ <i>Mastercam Copilot</i> ”.
“ <b>Output(s)</b> ”	means all information, outputs, data, responses, replies and other communications generated through use of the Mastercam Copilot.
“ <b>Privacy Notice</b> ”	means the Licensor’s privacy policy concerning the personal information and/or personally identifiable information controlled and processed by the Licensor in connection with the Mastercam Copilot (as updated from time to time and available at the following URL: <a href="https://www.mastercam.com/privacy/mastercam-copilot-software-privacy-notice/">https://www.mastercam.com/privacy/mastercam-copilot-software-privacy-notice/</a> ).
“ <b>Prompt(s)</b> ”	means instructions, queries, prompts, and other information and/or data inputs submitted to the Mastercam Copilot.
“ <b>Purpose</b> ”	has the meaning given in Section 3.1.4.
“ <b>Site</b> ”	the website (and all associated relevant pages) owned and operated by the Licensor through which an online limited version of the Mastercam Copilot may be accessed and used.
“ <b>Site Terms of Use</b> ”	any website terms of use applicable to all access and use of the Site.
“ <b>Site User</b> ”	an individual accessing the Site.
“ <b>Transparency Notice</b> ”	the Licensor’s document and/or statement containing technical and functional information concerning the operation of the Mastercam Copilot (as updated from time to time and available at the following URL: <a href="https://www.mastercam.com/privacy/mastercam-copilot-transparency-notice/">https://www.mastercam.com/privacy/mastercam-copilot-transparency-notice/</a> ).

### 2. LICENSE GRANT

2.1. Subject to Section 2.2, the Licensor hereby grants the Site User the License.

2.2. The License is fully revocable in the Licensor’s absolute discretion and granted subject to the Site User’s strict compliance with the following conditions:

2.2.1. the Mastercam Copilot and Outputs may only be used or accessed:

- 2.2.1.1. for the Site User’s personal and/or internal (*i.e.*, non-commercial) business purposes; and
- 2.2.1.2. where the Site User has: (a) accepted the Site Terms of Use (including all terms and conditions incorporated therein or by reference); and (b) unconditionally accepted these Terms of Use; and
- 2.2.1.3. the Site User shall not use or access the Mastercam Copilot:

- 2.2.1.3.1. to request or obtain Outputs concerning or comprising machine safety advice; or
- 2.2.1.3.2. in breach of applicable laws, regulations, third-party rights, or any policy, instruction, and/or guideline issued by the Licensor (from time to time).

### 2.3. The Site User shall not:

- 2.3.1. modify, copy, distribute, interrogate, or reverse engineer the Mastercam Copilot or its underlying technology or use the Mastercam Copilot to create (or assist another person to create) a competing product and/or solution to the Mastercam Copilot or related software;
- 2.3.2. use any data extracting techniques (including data scraping) to access the Mastercam Copilot in a manner that sends more requests to the servers than a human can reasonably produce in the same period of time using a conventional online web browser;
- 2.3.3. use the Mastercam Copilot or any Outputs in a manner that infringes, misappropriates, or otherwise violates any third party's rights; or
- 2.3.4. enter any personal data or personally identifiable information in the free text fields available for Prompts.

## 3. ACKNOWLEDGMENTS AND TRANSPARENCY

### 3.1. The Site User acknowledges and agrees that:

- 3.1.1. Section 4 (LIMITATIONS AND DISCLAIMERS) applies to all use of the Mastercam Copilot and Outputs;
- 3.1.2. the Mastercam Copilot: (a) is under continuous development; and (b) uses generative artificial intelligence systems that simulate human interaction and conversation;
- 3.1.3. the Mastercam Copilot **is not intended to be used as a safety component of a product**;
- 3.1.4. the Mastercam Copilot is an automated service that is: (a) intended to perform narrow procedural tasks; (b) designed **as an aid** to: (i) the navigation of documentation and the Site; and (ii) use of the Licensor's proprietary software (the "**Purpose**");
- 3.1.5. it shall not use the Mastercam Copilot or Output for any purpose other than the Purpose and in compliance with these Terms of Use; and
- 3.1.6. further information concerning the technology (including third party infrastructure, systems, and technologies) powering the Mastercam Copilot may be obtained through the Transparency Notice.

## 4. LIMITATIONS AND DISCLAIMERS

### 4.1. Given Section 3 (ACKNOWLEDGMENTS AND TRANSPARENCY), the Site User unconditionally and irrevocably agrees that:

- 4.1.1. the Mastercam Copilot and the Output is made available by the Licensor strictly for the Purpose and on: (a) an "*as is*" and "*as available*" basis; and (b) a strict **non-reliance** basis;
- 4.1.2. the Licensor cannot, and does not, warrant, undertake, covenant, or represent that Outputs are complete, accurate, or fit for the Site User's specific requirements;
- 4.1.3. the Site User assumes sole responsibility for its reliance on Outputs obtained through its interaction with the Mastercam Copilot and the conclusions or courses-of-action drawn from such use; and
- 4.1.4. the Licensor may limit and/or discontinue use and access to the Mastercam Copilot at its sole discretion and with or without giving prior notice (including by restricting the quantity, type and/or content of enquiries made to the Mastercam Copilot and Outputs drawn from use of the Mastercam Copilot).

### 4.2. Except if, and to the extent, binding applicable law requires otherwise:

- 4.2.1. the Licensor makes the Mastercam Copilot and Outputs available without any warranties or guarantees of any kind, express or implied, including but not limited to the warranties of merchantability, fitness for a particular purpose, accuracy, completeness, reliability, security, or non-infringement; and
- 4.2.2. the Site User is solely responsible for any damages or liabilities arising from its use of the Mastercam Copilot or Output.
- 4.3. For the avoidance of any doubt, the Licensor is not under an obligation to make available, update, maintain, correct any errors or bugs or in any way improve the Mastercam Copilot and makes no representation whatsoever about the quality, availability, security, or Output of the Mastercam Copilot.
- 4.4. IN ALL CASES, THE SITE USER AGREES THAT LICENSOR AND ITS AFFILIATES, AND THEIR RESPECTIVE OFFICERS, DIRECTORS, EMPLOYEES, AGENTS, LICENSORS, SUPPLIERS, AND PARTNERS, ARE NOT LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL, EXEMPLARY, OR PUNITIVE DAMAGES, OR ANY OTHER DAMAGES OR LOSSES OF ANY KIND, ARISING OUT OF OR RELATING TO THE SITE USER'S USE OF OR INABILITY TO USE THE MASTERCAM COPILOT, OR ANY DATA OR INFORMATION PROVIDED BY OR OBTAINED FROM THE MASTERCAM COPILOT (INCLUDING OUTPUTS), WHETHER BASED ON CONTRACT, TORT, NEGLIGENCE, STRICT LIABILITY, OR ANY OTHER LEGAL THEORY, AND WHETHER OR NOT THE SITE USER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES OR LOSSES.

## 5. PROMPTS

### 5.1. The Site User:

- 5.1.1. is responsible for all Prompts submitted to the Mastercam Copilot (including the quality, sufficiency, completeness, and accuracy of Prompts);
- 5.1.2. acknowledges and agrees that the quality and content of Outputs is dependent on the quality and content of the Prompts;
- 5.1.3. warrants, represents, undertakes, and covenants to the Licensor that it has all Licenses, permissions, and/or consents necessary to submit the data and/or information contained in the Prompts;
- 5.1.4. agrees that:
  - 5.1.4.1. it has been presented with, or informed of the existence and location of, the Privacy Notice;
  - 5.1.4.2. it shall comply with these Terms of Use (and, in particular, the obligations set out under Sections 2.2.1.3 and 2.3);
  - 5.1.4.3. it shall not submit Prompts to the Mastercam Copilot containing confidential and/or commercially sensitive information (including personal data and/or personally identifiable information).

## 6. PRIVACY AND DATA

### 6.1. The Site User acknowledges and agrees that the Licensor (or other members of the Sandvik Group) may:

- 6.1.1. in connection with the provision and development of the Mastercam Copilot and with respect to personal data and/or personally identifiable information, collect and process such personal data and/or personally identifiable information in accordance with, and as described in, the Privacy Notice; and
- 6.1.2. with respect to all other data and/or information submitted to the Mastercam Copilot (e.g., in a Prompt), use such data and/or information for its lawful business purposes including as follows:
  - 6.1.2.1. making the Mastercam Copilot functional and available for use (including in accordance with these Terms of Use);
  - 6.1.2.2. providing support to the Site User;

- 6.1.2.3. verifying compliance with these Terms of Use;
  - 6.1.2.4. planning and implementing improvements to the Mastercam Copilot and its proprietary software;
  - 6.1.2.5. enabling scalability planning and performance monitoring activities to be carried out;
  - 6.1.2.6. evaluating adoption rates and the success of new features and releases of the Mastercam Copilot and/or its proprietary software;
  - 6.1.2.7. creating training data or training the Mastercam Copilot or other products and/or services; and
  - 6.1.2.8. evaluating current and future performance of the Mastercam Copilot or related proprietary software.
- 6.2. Further information concerning the Licensor's use of collection and use of data submitted to, or generated by or through use of, the Mastercam Copilot is contained in the Transparency Notice (including the descriptions of the third-party infrastructure and technologies used to power the Mastercam Copilot).

## **7. OUTPUTS**

- 7.1. Given that the content, data, and/or information contained in the Outputs derives from intellectual property rights and/or confidential information belonging to the Licensor (and its licensors), the Licensor reserves all rights in, and title to, the Outputs (including all intellectual property rights in the same).
- 7.2. As between the Parties, the intellectual property rights in the Outputs shall vest in the Licensor immediately on creation and if such intellectual property rights do not, as a matter of applicable law, vest in the Licensor immediately on creation then the Site User hereby: (a) holds such intellectual property rights on trust for the Licensor; and (b) assigns or shall take all necessary steps to assign all intellectual property rights in the Output to the Licensor.
- 7.3. Outputs are licensed for use for the Purpose and in accordance with these Terms of Use under Section 2.

## **8. INDEMNITY**

The Site User agrees to indemnify, defend, and hold harmless the Licensor and its Affiliates, and their respective officers, directors, employees, agents, licensors, suppliers, and partners, from and against any and all claims, liabilities, damages, losses, costs, expenses, or fees, including reasonable attorneys' fees, arising out of or relating to your use of or inability to use the Mastercam Copilot, or any data or information provided by or obtained from the Mastercam Copilot (including Outputs), or any violation of these Terms of Use, the Site Terms of Use, or any applicable laws or regulations by the Site User or anyone using the Site User's account or credentials.
